## *IART breeding contract for the 2024 breeding season*

### Between the breeder and "GD Sporthorses" srl (G.D.S.) it is understood that:

"GD Sporthorses" upon receipt of this contract accompanied by the requested payment undertakes to:

1. Provide the breeder or the establishment center with a dose of refrigerated semen after it has been ordered by telephone +33 7 77 99 08 76 or by e-mail info@quellhomme.dehus.com before 8 a.m.
2. The non-execution or the bad execution of the delivery or the conservation of the semen are the responsibility of the carrier, the breeder or the center of establishment and not that of G.D.S. The breeder and the breeding center are not authorized to use the semen for a broodmare other than that indicated on this contract. If this were the case, the breeder is liable to a fine of €5,000 including tax.
3. The stallion will be collected on Monday - Wednesday and Friday of each week (pay attention to public holidays for carriers)
4. The technical costs are valid for the current season in non-reportable. The technical costs do not include the costs of transportation.
5. The breeding season will start on March 15 and end on August 15, 2024.

6. Semen will be delivered for a maximum of 3 cycles per mare. Beyond that, if the mare is not pregnant, an additional dose of refrigerated semen will be made available only after presenting a recent and negative bacteriological certificate.
7. In the event of force majeure (sale, death, accident, sterility of the stallion, etc.), the stallion owner cannot commit himself to the breeder.
8. In the case of embryo transfer, stud fees will be charged per embryo successfully transferred and resulting in a live foal.

**The breeder agrees with "GD Sporthorses" srl to:**

1. Pay the technical costs: €106 incl. tax on signing the contract for the provision of the semen (transport costs not included) by transfer to our bank account. In the absence of payment, the contract is invalid and the mare cannot be inseminated.
2. Pay the balance for the genetics: €636 incl. tax in 2025 within 48 hours of the birth of the foal. You will receive the invoice on the 1st day of the month of the expected birth of the foal.
3. Return the last insemination or vacuity certificate within 90 days, specifying whether the mare is remaining or not. The certificate of vacuity must be issued by a veterinarian. If the breeder fails to declare that the mare is non-pregnant, stud fees will automatically be charged.
4. Notify G.D.S. birth by email within 48 hours. Upon receipt of payment of the balance, G.D.S. then sends the Breeder by email the Declaration of Birth which allows him to register the foal.
5. If the foal is declared without having paid the balance, the balance for the genetics is increased by €2,500 incl. tax (Two thousand five hundred euros) without possible appeal.
6. Pay transportation costs for each seed shipment.

**In the event of vacancy, disaster, late declaration of birth, unpaid bills:**

1. In case of widowhood on 09/30/2024 or if the mare is not pregnant with the stallion, the breeder transmits to G.D.S. before 01/10/2024 by email a veterinary certificate specifying this condition.
2. In the event of late payment of G.D.S invoices, late penalties are applied from 10 days after the birth of the foal, in accordance with the provisions referred to under articles L441-3 and L441-6 of the Commercial Code: equal penalties at three and a half times the legal interest rate in force on the due date, without the need for formal notice. Any reductions and guarantees that the breeder could benefit from from G.D.S. are then deleted. The declaration of birth is only issued after full payment of the sums due and late payment penalties.

**Conditions concerning inseminations:**

1. A period of eight days between the sending of the contract and the payment and the arrival of the mare at the placement center makes it possible to properly plan her reception.
2. The mare must be in good health, in good general condition, regularly dewormed, must be vaccinated against tetanus, influenza and rhinopneumonia (5-7-9 months).
3. The mare must undergo ultrasound monitoring from the start of heat until ovulation by the veterinarian of the placement center. The buyer releases GD Sporthorses from any liability in the event of a claim in the center and in the event of unavailability of semen.
4. Risks: There are inherent risks in herding horses and breeding them. The breeder must find out about this from the installation centre.

**Informed consent of the owner: The breeder or his representative who declares himself officially authorized by the breeder, affirms to have been informed in clear terms and to have fully understood this contract. He accepts the clauses and acknowledges that no guarantee has been given to him as to the expected result. In the event of a dispute concerning the application of this contract, only the jurisdiction of the registered office of "GD Sporthorses" is competent.**
